APPLICATION FOR SEPTIC TANK REPLACEMENT CONSTRUCTION PERMIT INSTRUCTIONS

The size and use of the septic tank and drainfield need to be determined before <u>any</u> work commences.

- 1. Must contact TriCounty Health Department for records of the existing onsite wastewater system.
- 2. Fill out the application completely.
- 3. Submit the following:

- □ Application
 □ Size and manufacturer of tank to be installed.
 □ An official floor plan of each level of the building
 □ Fee \$100.00 (Non-refundable and subject to change)
- 1. THE NEW SEPTIC TANK CAN BE BURIED TO THE OUTLET.

Current Tax I.D. Form (if no health department record)

- 2. THE SIZE AND MANUFACTURER INFORMATION IMPRINTED ON THE TANK MUST BE EXPOSED.
- 3. INSTALL ACCORDING TO MANUFACTURER'S INSTRUCTIONS.
- 4. MANHOLES ON TANK MUST BE ACCESSIBLE FOR INSPECTION.
- 5. SEPTIC TANK MUST PASS A LEAK TEST PRIOR TO COVERING.
